Call to Order

Dr. Carlton explained that the audience comments had not changed. The Board decided to move it to the beginning of the Board Meeting. Dr. Carlton stated the Board does not serve as an appeal Board for the ADC. The Board and the CDD will be having a meeting on the street tree symposium. In regards to the Next Door website the Board has no affiliation of any form with the website. Dr. Carlton stated The Neighbor Watch Program is an independent entity.

Approval of Minutes

On Motion by Mr. Alfin, seconded by Dr. Carlton, with all in favor, the Board Approved the Meeting Minutes of the Board of Directors of May 29, 2015.

Committee Reports

Community Manager - Mr. Railsback (SSMG)

Mr. Railsback provided the standard reports that are in your packets. Mr. Railsback spoke about the resignation of a PLM Vendor.

Finance report - Mr. Alfin

Mr. Alfin reported that the Association's financials are in good standings as of the end of May. There was a discussion about the properties that received notices pertaining to Commencement to Construction.



Problematic Properties - Dr. Robert Jay Carlton, Mr. Murray Salkovitz

Mr. Salkovitz reported the amount collected to date was \$172,000.00. Mr. Salkovitz spoke about the lot that GHMA owns that is for sale at 60 Riverbend Drive.

Architectural Design Committee (ADC) Liaison – Mr. Vic Natiello

Mr. Natiello discussed the changing of the ADC letters to property owners. Mr. Natiello discussed the changing of the ADC comment sheets. Communications/Oak Tree Liaison - Mr. David I. Alfin

Mr. Alfin stated that The Oak Tree is on schedule and more residents are beginning to send in articles. Mr. Alfin would like the Board to discuss advertising and advertisers. - 2. Street Tree Symposium Update Dr. Robert Jay Carlton
 Dr. Carlton provided the proposed topics for the Street Tree Symposium and their
 Historical perspective, benefits and burdens, possible solutions, legal, liability and financial
 consideration. The second draft of the Street Tree Symposium is posted on both the Grand
