President's Message

RESPONSIBILITIES OF THE GHMA

As a follow-up to the President's message in the November edition of the Oak Tree which was entitled "Who's Who And What Do they Do?" I wanted to elaborate by further addressing the specific responsibilities of your homeowners association.

Following unique events such as we experienced with Hurricanes Matthew and Irma, questions generally arise regarding services to our community. In the aftermath of Irma, I spoke with a number of residents who had sent e-mails to our management company. Their comments, combined with input received throughout the year, made me realize that although many residents are well informed regarding the Master Association, a misperception exists among some concerning the duties and responsibilities of the GHMA. Hopefully, the following will provide clarification in this regard.

To begin, the Master Association cannot function outside of the responsibilities designated in the Grand Haven governing documents and State Statute 720. The Association does not have the authority to take action because:

- A group of property owners demand that they do so.
- It would provide assistance to homeowners.
- No one else is taking action so the Master Association must do so.
- I elected you and therefore you should do what I want.
- That is why I moved into a deed restricted community.
- If you can fine property owners, you should be able to provide services for them.

These statements are not factual but are a sample of beliefs that have been expressed by some residents at various times in the recent past. Whether you consider it fortunate or unfortunate, fair or unfair, right or wrong, the legal functioning of the GHMA is narrow in scope. The primary responsibility and vision statement of the Association is as follows:

"to enforce both equitably and in a timely manner all Covenants, Conditions and Restrictions (CC&R's) pursuant to the Declaration, while fixing, levying, collecting and enforcing payment from Association members all charges and assessments in accordance with Florida law"

In addition, the Association is also responsible for:

- Management, accounting and legal services, as well as securing required insurance coverage.
- Oversight of the Architectural Design Committee (ADC), Private Lawn Maintenance Program (PLM) and facilitating the Fine Committee
- Communication with Association members via scheduled meetings and newsletter (Oak Tree).
- Other responsibilities as stated in the Grand Haven governing documents.

Every property owner should have received a hard copy of both the Master Declarations and your Village Declarations at the time that you purchased your property. If you have not and wish to view them, please go to the GHMA web site at grandhavenhoa.com and access the link to "Governing Documents". The Master Declaration addresses the establishment of Grand Haven as a deed restricted community, while the Village Declarations are specific to each Village and the applicable CC&R's.

Although the GHMA Board is always interested in the concerns of property owners and will provide assistance and support whenever possible, we do not have the ability or authority to exceed the legal limitations placed upon us. In addition, doing so could potentially expose the Association to litigation, which in turn, could result in additional costs to all property owners. The Board is committed to supporting the needs of our Association members, but doing so in accordance with our governing documents. Although this might not meet the expectations of some of our residents, it is a reality under which your Board must and will function. Despite the best of efforts it is virtually impossible to meet all of the needs of 1901 property owners and approximately 4500 residents. However, the Board is committed to fulfilling our responsibilities to the residents of Grand Haven in a manner that is consistent with our governing documents and legal limitations.

As always, your participation and cooperation is most sincerely appreciated in our efforts in achieving that goal.

Disaster Preparedness Protocols

The following CDD Operations Staff Protocols were presented at a recent disaster preparedness session:

The following actions will be taken when wind is forecast to reach tropical storm force (39- 73 mph sustained winds.) Data will be obtained from Flagler Emergency, Weather Underground and/or NOAA.

- When actions are to be taken, CDD and Amenity Center Staff will notify community ASAP.

Gates

- Controlled Access Gate Officers to be released.
 - ◇ To prevent wind driven projectile damage, CDD Operations Staff will open and remove gate arms at the North, Main and South Gates and open The Crossings and Wild Oak Swing Arm Gates, in advance of storms or at the discretion of the Operations Manager.
 - ◇ To prevent electronic circuit board damage due to power surges, all gate circuit boards will also be removed.
- Controlled Access Gate Officer return
CDD Operations Staff will close The Crossings and Wild Oaks gates and reinstall gate arms and circuit boards when tropical storm winds forecast to clear and weather allows gate arms to be safely reinstalled.

Amenity Centers (under direction of GH OPS Mgr.)

- Amenity Staff will close amenity centers in advance of storm.
- CERT Team has authority to use the amenity facilities as needed for CERT Team operations.
- Amenity Staff will reopen amenity centers when tropical storm winds forecast to clear or at the direction of the Operations Manager

Tennis courts

- Amenity Staff will remove wind screens and lower nets

Pool Deck Areas — Amenity Staff will:

- Tie down chairs and chaise lounges
- Move tables to corner and secure
- Place umbrellas, life preservers, flags, etc., into equipment room

Other

- CDD Operations / Amenity Center staff will place the golf cart in Village Center Shed
- CDD Operations Staff, Amenity Center Staff or CERT members will lower radio antenna mast till storm clears.

Communications

- GH CDD OM and Amenity Center Management Company will coordinate agreement regarding all actions to be taken
- GH CDD OM will contact debris removal and tree service contractors for staging
- GH CDD OM contacts the BOS Chair and informs District Manager of actions to be implemented
- GH CDD District Management Company sends E-blast to community regarding actions to be implemented
- Amenity Center Management Company also sends E-blast to community regarding actions to be implemented
- GH CDD GMRS Radio Station (462. 575 mHz) (CH 16) establishes controlled radio net for use by CDD, Master Association, Amenity Center Management Company and the CERT staff
- Residents can tune into CH 16 (462. 575 mHz) on a GMRS Radio (available at Walmart or Amazon) to listen to GH operations.

- 4C' s — Common Areas Main Debris
- Shaw — Common Area Trees (at direction of GHOM & GHHC)
- S.E. Cline — Back up for common area trees, Major infrastructure damage
- City of Palm Coast — Memorandum of understanding between GH CDD & CPC for Common Areas
- City of Palm Coast's contracted Waste Hauler will pick up private property debris
Number of private property debris pick up to be established by CPC & contracted Waste Hauler (Waste Management).

Neighborhood Watch

We are delighted to note that we have many new residents joining our lovely community and we welcome you to Grand Haven! There is much to enjoy and do here with friends and neighbors.

Our Neighborhood Watch volunteer program is supported by the Flagler County Sheriff's Office, and is a program of neighbors watching out for and caring about neighbors. Our mission is as follows: The Grand Haven Neighborhood Watch has been organized to promote the awareness and education of residents in crime prevention and to help maintain our quality of life. Our mission is to keep our neighborhood as safe as possible, to encourage residents to be observant, report all suspicious behaviors and all crime incidents to the police and follow stated procedures to make pertinent crime information available to the community. Volunteer Village Captains should maintain communication with village residents in person, by phone or email, working toward our goal of zero crime in our community.

Sheriff Staly shared with us that there are very few crimes committed here in GH, and the few that are, tend to be crimes of opportunity, easily averted with some care, awareness and attention. By being observant of what is happening to neighbors, their homes and property, noting any irregularities and checking on it, we help keep Grand Haven the safe community it is. If any resident sees a crime in progress, call 911. If you see something suspicious, or out of the ordinary, call the police non-emergency 313-4911 number and report it. Neighbors help neighbors.

Throughout Florida, many scams are being perpetrated to part any residents from their money. The Florida Attorney General's Office supports a trained volunteer program, Seniors vs Crime, to help people who think they have been victimized with any fraud or scam by contractors, phone calls, through the mail or emails. Ken Seymour is the local office manager and his group may be contacted at: 386-586-2634, or email at: svckensey@gmail.com. There is help!! We are reminded: Use caller ID, and don't answer the phone if you don't recognize the caller, let them leave a message.

Never wire or send money to anyone calling; especially from the IRS or SSI (Social Security). No government agencies will contact you by phone, nor ask for you to wire money. If it's another agency, don't call back the number they leave, look up the agency main number. After a disaster, avoid sending money to charities other than the well-known, long established ones. Pop ups tend to be scams.

Learn more about health product scams at: consumer.ftc.gov before purchasing.

Avoid "Imposter" scams and "You've Won" scams. Avoid depositing a check and then sending the cash from it by wire or otherwise. You are responsible for any checks you deposit, not the bank.

Playing foreign lotteries is illegal and they are usually scams. If you have to pay ANYTHING to receive your "won" funds, don't. It's a scam.

Avoid any extended car warranty offers made by mail or email, and call your dealer to check directly. Scammers can find and use your date of purchase and vehicle type easily. Carefully check all your monthly statements.

In the future, programs like Seniors vs Crime, Women's Self Defense, the Star and Cops programs, and the Sheriff's Office will be invited back to Grand Haven to introduce and discuss their programs, distribute useful materials and provide free, valuable seminars to interested groups of residents.

We appreciate and invite more volunteers to join us in our NW program so that every Village in Grand Haven is well represented and informed. Village captain volunteers can use help reaching people in their Villages. Together we continue to build a stronger, informed, safer and caring community. Thinking of Making Changes To Your Home?

Are you thinking of updating or making changes to the outside of your home?

Welcome to new homeowners and long-time residents. As we live in a deed-restricted community, we must be aware of the "Standards" when we are considering any changes to the outside of our homes.

This article is a review for long-time residents and a resource for new homeowners. You can find all you need on the **Master Homeowner Association** website (www.GrandhavenMHOA.com), then click on the **Architectural Design Committee** (ADC) tab. The standard guidelines and request forms are located on this tab, under "Forms/Standards".

On this tab you will find *ADC Standards, ADC Application Form, Well Agreement* and other items related to changes in our community.

Remember if a plant dies and you replace with the same plant, or if you have mildew you need to remove from your roof, those items are maintenance and do not require **Modification ADC** approval. But if you change your landscaping, add a paver driveway, change a door, slider or color of the exterior of your home, etc, you need the MADC's approval.

What you need to do is:

- Complete the Application form, with vendor information and sign it.
- Explain in detail what changes are happening.
- Include diagrams, pictures or other spec information needed to explain changes.

Submit all of this information to Southern States Management Group (SSMG) (386-446-6333). Application is FREE unless you are making a major change, and then there is a refundable deposit. *If you have any questions on what is necessary for submission, just call Michele Logan at SSMG.* You can drop your completed application in the White Lock Box on Marlin Drive.

MADC meetings are scheduled on the first and third Wednesday of each month starting at 9:30am. The deadline for submittals is the Wednesday prior, by 4pm. We encourage you to attend the meeting to explain just what you envision the outcome of your project to be. We are all committed to keeping Grand Haven up to the standards we all want.

FLAG RESOLUTION

Every so often, the GHMA Board of Directors and your management company are faced with an issue that has the potential of being extremely controversial and has the ability of generating an emotional response by both members of our community and those beyond the confines of Grand Haven. One such issue pertains to the flags that are authorized to be displayed in accordance with both State law and our existing governing documents.

Florida Statutes, section 720.304(2)(a) states, "Any homeowner may display one portable, removable, United States flag, or the official flag of the State of Florida in a respectful manner, and one portable, removable official flag, in a respectful manner, not larger than 4 ½ feet by 6 feet, which represents the United States Army, Navy, Air Force, Marine Corps, or Coast Guard, or a POW-MIA flag, regardless of any covenants, restrictions, bylaws, rules, or requirements of the association."

In conjunction with the above, The United States Code (4 U.S.C) states, "The flag of the United States, shall be thirteen horizontal stripes, alternating red and white, and the union of the flag shall be forty-eight stars, white in a field of blue" *

The members of the Board of Directors are in unanimous agreement with the above statutory requirements and have resolved that the flags stated above, along with the definition of the U.S. Flag, shall be included in our governing documents.

SSMG is aware that some residents may take exception to the Board's position. They, however, will hopefully understand that the cause that their flag represents is not the issue. It may be a cause that we all approve and perhaps, passionately support. However, if it is not one of those specific flags included in State Statute 720.304 (2)(a) and our governing documents, it is not among those to be displayed within our community. This will never be an issue that is based upon what the flag represents, but rather, criteria established by State law and confirmed by your Association.

It is hoped that all residents will make this distinction and realize that this is an issue that should be based upon the facts, not emotions regarding the causes that any given flag represents. We, as your management company, are committed to implementing our governing documents in a fair and equitable manner and ask that you join us in this mission. As always, your support and participation is truly appreciated and we welcome you to join us at our monthly Association meetings.

**On the admission of a new State into the Union one star shall be added to the union of the flag; and such addition shall take effect on the fourth day of July then next succeeding such admission.*

EAGLES AT GRAND HAVEN

As we approach the end of August, many await with hope and anticipation that our resident Bald Eagle pair, Romeo and Juliet, return to their nest, as they have like clockwork for the past 10 years. Hope and anticipation are two of the blessings of youth that have sadly disappeared from too many adults. They are quite possibly two of the most important components of joy.

To witness the first glimpse of Romeo and Juliet's arrival is truly a joyous occasion and confirms the beauty of nature, and how nature can manage without the assistance of human involvement. It confirms the Eagle's commitment to each other and their nest. It confirms they have a built-in GPS, as they find their way back home year after year (as their off-spring often do!). It shows their faithful affection to their mate confirming their strong desire to reproduce.



Bald Eagles in the wild have an average life-span of approximately 25-30 years. If healthy they can often successfully breed until they perish. The ages of Romeo and Juliet are an unknown, however, they are at least in their late teens. Over the past 10 seasons they have produced 19 off-spring with an unprecedented 100% success rate (fledge) each year.

During the summer months (off-season) the empty nest has been a favorite resting spot to a pair of Osprey, who think it's perfect for their needs, as they busy themselves moving sticks and delivering fish then dining in the nest. One eagle that is approximately 5 years (almost mature) has frequented the nest at length several times appearing quite "at home". Could this be one of Romeo and Juliet's off-spring? Very possible!

Well, should any eagles or other raptors be present when Romeo and Juliet return, they will likely be quickly escorted away by the Eagles who claim that nest!

BIKE SAFETY

“The roads are a cooperative system. They are a common space in our communities where we all interact daily. Our conduct on the roads influences the quality and livability of our communities.”

This is how the article begins on the website, **florida-bicycle.org**. It speaks to Sharing the Road with cyclists. Share the Road signs indicate the likelihood of cyclists on the roadway. They are used where the road is not wide enough for bicycles and cars to be operated safely within one lane. Therefore, “share the road” means “one after the other.” The bicycle driver, or group of cyclists, has the right of “first come, first served” and the full use of lane. Motorists wishing to pass, must yield and wait until it is safe to do so.

Bicycle drivers usually ride in the right half of the lane, to offer visibility and easier passing for motorists. But they are not required to stay out of the way or to share *their lane* if it is not wide enough for side-by-side operation. The best position for cyclists in a narrow lane is one that makes it clear to a following motorist that he or she must change lanes (typically, this is between the right tire track and the center of the lane, but varies based on many dynamic conditions). There are times when cyclists need to ride on the left side of the lane: to avoid a hazard or bad pavement; when traveling the speed of traffic; preparing for a left turn; or even to strongly discourage a motorist from passing when it is not safe.

Many conflicts and crashes are caused by impatient drivers. When you encounter a bicycle driver, take a moment to observe the roadway. In many cases it is not necessary to pass a cyclist right away, or at all:

- Is there a red light, stop sign or stopped traffic ahead?
- Is there an opportunity to pass with greater clearance in a short distance?
- Are there vehicles at cross streets that might turn into the oncoming lane as you are passing?
- Is the cyclist riding within a few mph of the speed limit?
- Are you on a residential street with speed bumps?
- Are you planning to turn off that road in 500 feet?

Once you have assessed the situation and determine it is safe and necessary to pass, give the cyclist plenty of space. The law requires at least 3 feet, but let's be honest, you really can't determine exactly where the right side of your car is in relation to what you are passing.

Go ahead and change lanes, you can't go wrong with that. On high-speed roads, reduce your speed as you pass. Even with plenty of clearance, it is not safe or considerate to pass an exposed human being at 70mph.

Take a deep breath, you have nothing to lose but stress.

Everyone is in a hurry. And lots of things get in the way: freight trains, red lights, other motorists, buses, etc. will all seem to be in your way throughout your journey.

Again, think before you pass. If there is stopped traffic, a stop sign, red light or speed bump ahead, you'll gain nothing by passing. Save your gas.

A cyclist or group of cyclists in the road represents the most minor and momentary delay. Waiting a few seconds to pass a cyclist safely will not affect your total trip time at all. Injuring another road user because you are impatient and frustrated will cost you a lot more than a few seconds.

Purposely passing a cyclist too close with the intent to intimidate is ASSAULT. Passing too close at high speed because you are in a hurry is RECKLESS ENDANGERMENT.

If you see another motorist assault or endanger a cyclist, please call the police. We're somebody's daughter, son, mother, father, sister, brother, wife or husband. We might be your friend, neighbor, co-worker or doctor. Help us ensure the safety of Florida cyclists and the quality of our communities by driving cooperatively and reporting reckless driving and hostility.


