(hereinafter "Association") through its Board of Directors shall have the authority to adopt rules and regulations governing the administration and operation of the Common Areas;

WHEREAS, Section 5.1.3 of the Declaration gives the Association the power to do any and all lawful things which may be authorized, assigned, required or permitted to be done by any Subordinate Declaration;

WHEREAS, Section 5.1.3 of the Declaration provides that the Association shall have all powers and shall perform all duties set forth in the Subordinate Declaration where the Association is serving as a Subordinate Association to Owners within certain Villages by reason of: 1) being named as the association of such Owners in a Subordinate Declaration or 2) being the surviving entity of a merger with a previously established Subordinate Association;

WHEREAS, Section 1.1.31 of the Declaration defines Subordinate Declaration as the instrument or document, and any amendments thereto, which is filed of record with respect to the Village or Villages within the Property and which may impose covenants, conditions, easements, and restrictions with respect to lots, dwellings, or commercial sites or structures within such Village or Villages;

WHEREAS, every Subordinate Declaration gives the Board of Directors the power to promulgate and amend rules and regulations governing the use of the Lots or Residential Units;

NOW THEREFORE, the Board of Directors of the Association amends the Rule as follows:

Outdoor sales are prohibited on any Lot, tract, or location within the Grand Haven Community. The term "Outdoor Sale" means any garage sale, home sale, basement sale, yard sale, tag sale, attic sale, moving sale, junk sale, block sale,

estate sale, rummage sale, lawn sale or any other similar type of sale of tangible personal property, such as, but not limited to, arts, crafts, clothing, household effects, tools, garden implements, toys, books, recreation equipment or other used or secondhand items customarily found in and about the home.

Upon approval by the Grand Haven Master Association and subject to the following conditions, Outdoor Sales approved by and conducted under the auspices of the Community Development District, or its amenity management company, will be permitted on Village Center or Creekside Amenities Center property as long as:

- 1. All advertising of such events shall be limited to the confines of the Grand Haven Community.
- 2. Any such events will be attended exclusively by Grand Haven Residents and their invited guests.

Solicitation of any type is prohibited on the Residential Units within the Property. Solicitation is defined as the sale or lease of consumer goods or services, or the advertisement of such goods and services, in which the seller, without invitation, personally solicits or advertises the sale or lease via travel to Residential Units within the Property. Solicitation also includes an individual, or individuals, that travel door to door for political, charitable, religious or educational reasons.
